

## The Test Family

This record is being written primarily for the descendants of Albert Barclay and Lydia Ann Test, which group may well be called the South Dakota branch of the family.

Our records are incomplete, particularly as to dates and place names, but they are interesting to study. Two different families of our ancestors may be traced to the early days of this nation. The Lawrences and the Strawns were those two families.

The Lawrences perhaps lived in eastern Virginia from the time they came here from England, until they fled from Hampton, Virginia, to Ohio, during the slave insurrection led by Nat Turner, in 1831.

The first Strawn mentioned is of interest because he was a companion of William Penn when his party came to Pennsylvania on the good ship "Welcome", for the purpose of founding a colony. It is in the records of this branch of the family that we first find the name Test, when Margaret Strawn became the wife of Isaac B. Test. Isaac and Margaret were great, great grandparents of the present writer.

The following lists of names, dates, and any available comments, is the total of all material on our family records kept by many members in the past, largely by our grandmother, Lydia Ann Test, and assembled now with the help of her daughter-in-law, Maude Elizabeth Test, who had carefully guarded grandmother's old papers.

Since this work was started, including the stories of the Strawn and Lawrence families, we have been able to secure a copy of a Test history compiled by Mr. Nathan Hall, whose history goes back four generations earlier than the name Test entered our records. We are including the information Mr. Hall has sent us, for which we are deeply grateful. It has been added to these pages.

Each family group and each change in residence, every birth, marriage, or death, could tell its own dramatic story. We need only to use our imaginations to picture the way these ancestors of ours must have lived. Making a home for the children of each succeeding generation was their task, as it is ours.

## Strawn (sometimes spelled Straughn)

1.

Jacob Strawn, with his wife and 12-year old son, came to Philadelphia in 1682 with William Penn on the ship "Welcome". In a few years Jacob died, and the widow and son moved onto a farm of 700 acres, 40 miles north of Philadelphia. There is no record of the origin of this family in England, but we may safely assume they were members of the Society of Friends, or the Quaker Church.

2.

Jacob Strawn, who was evidently the son of the original Jacob Strawn, married Mary Buckman of Buck County, Pennsylvania. No dates given.

3.

Jacob and Mary Strawn were the parents of Jacob Strawn who married Christina Persel. No dates or places given.

4.

Jacob and Christina Strawn were the parents of eleven children:

Daniel Strawn and his third wife had no family.

William and Jane (Wilson) Strawn were the parents of a son, Erios Strawn.

Thomas and his second wife, Jane, were the parents of a son, Daniel J. Strawn.

John Strawn and his second wife, Martha, had no children, but reared Martha's  
 niece, Ann D. Lawrence, daughter of Robert and Elizabeth Lawrence.

The record of the Strawn family clearly gives the name of Isaac Test's  
 wife as Margaret. However, Mr. Hall's records show the lady's name was Martha.  
 We shall use both names in this record, although inclined to feel that Mr. Hall's  
 record is more accurate, since he is able to use many references in his work of  
 making these reports.

Isaac B. and Margaret or Martha (Strawn) Test were the parents of  
 Hannah, Daniel, Samuel, Rebecca, Zaccheus, Ann, whose dates of birth, marriages,  
 and all available information are given in the Test record which follows this.

There is, however, one difference of opinion in this generation. Anna  
 Hoopes Cope who contributed much data for this record, also listed a son named  
 David Test, who married Mary Young. Mr. Hall's record does not include a son named  
 David here, though he lists Samuel, completely neglected by Anna Cope.

Clayton and Hannah (Test) Lamborn were the parents of Emma and Lemuel  
 Lamborn.

Daniel and Ann (Lawrence) Test were the parents of:  
 Albert Barclay, Mary L., John Strawn, Martha, Deborah, whose names and dates are  
 given with all available details, in the pages that follow.

There is no record of children born to Samuel Test and Ann (Thompson)  
 Test, later information from Mr. Hall's records may give such names.

David and Rebecca (Test) Coppock were the parents of Isaac Test Coppock  
 and Ellen M. Coppock. (The name was sometimes spelled Coppec).

Zaccheus and Drusilla (Langstaff) Test were the parents of Margaret,  
 Benjamin, William, Ella, Effie, Emily, Lemuel, Elizabeth, Daniel, Sarah, and  
 Taylor, of whom more information is given in the pages that follow.

Samuel and Ann (Test) Barber were the parents of Isaac Barber.

8.

The eighth generation in this record of the Strawn-Test family includes, obviously, the children of all those mentioned above in the 7th generation. These are all listed in detail, with all available information, in either the Lawrence record which follows, or the record which continues Mr. Hall's data.

9 and 10.

The ninth generation here includes the grandchildren of those given above, who also are listed in subsequent pages in this report. These include descendants of the Marshalltown, Paullina, and Whittier, Iowa, branches of the family, and members and descendants of the South Dakota branch of the family.

Although our record may be far from complete, we know the ninth and tenth generations of the family are scattered from the east coast to California, from Minnesota to Texas, and include an assortment of names: Allen, Branson, Crane, DeVries, Galener, Gilliland, Hampton, Kehrl, Long, Lloyd, Mathison, Medhus, Peterson, Stanley, Stoll, Wapshall, Welty, Woodridge, Young, and even, believe it or not, a few Tests!

## Lawrence

1.

The record of the Lawrence family begins with a Thomas Copeland whose death occurred in the 11th day of the fifth month, in 1794. His age was about 70 years. The place in which he lived and died is not mentioned by this early record, which had been copied in the handwriting of Lydia Ann Test, who kept the old Quaker custom of using the number of the month, but never the name of the month of the year. Mary Copeland, wife of Thomas, died 30th of the 9th month, 1794. Age about 75 years.

Thomas and Mary Copeland were the parents of:  
Millicent Copeland, b 11th of the 11th month, 1751, died 7th of the 1st month, 1815.  
Married Robert Lawrence (b 20th of the 10th month, 1752, died 30th of the 9th month, 1807.)

Robert and Millicent Lawrence were the parents of:  
Margaret, 19th day of 2nd month, 1778, died 13th of 5th month, 1793  
Mary b 25th of 11th month, 1779, died 21st of 11th month, 1857  
Samuel b 30th of 3rd month, 1781, no record of marriage or death  
Dancy, b 26th of 1st month, 1783, no record of marriage or death.

Robert, b 21st of 1st month, 1785, married Elizabeth Denson who died in 1811. No record of Robert's death.

Thomas, b 17th of 2nd month, 1787, died 17th of 12th month, 1857. Married Isabel Harris (died 10th of 10th month, 1824, at age of 21 years, 6 mos. 8 days). Also married Deborah Rich (Prethlow) whose birth date is not recorded but who was married to Dr. John Prethlow 1st of 10th month, 1817. Married to Thomas Lawrence 26th of 4th month, 1826. Deborah died 30th of 11th month, 1878.

Martha born 10th of 2nd month, 1791, died 23rd of 9th month, 1873. Married Morris Nixon and (later) John Strawn (b 6th of 6th month, 1793, died 4th of 9th month, 1795\*)

Notes on the above Martha Lawrence written by Luella Test: "Martha's father, Robert Lawrence, was a planter and slave holder in Virginia. March 5, 1823, she married Morris Nixon, who died a year later. At the time of the insurrection of the slaves in Virginia, led by Nat Turner (1831) the family, who were Friends or Quakers, fled from their home near Hampton by hiding in swamps by day and travelling by night. They crossed the Ohio river at Wheeling and settled at Mt. Pleasant, Ohio. Here March 20, 1836, Martha was married to John Strawn, whose name was sometimes spelled Straughn. John died in 1858. Martha possessed what was considered in those days a substantial fortune and was beautiful of form and countenance. From the time of her last marriage, her home was at Salem, Ohio. After moving to Ohio she inherited slaves but did not sell them. There were given their freedom papers."

Anna Hoopes Cope contributed this note on Martha: "When Elizabeth Denson Lawrence died at the birth of her daughter, Ann D. Lawrence, Martha Lawrence (Nixon-Strawn) Elizabeth's sister-in-law, took the baby, only a few hours old, and reared her. Ann was my grandmother, Mrs. Daniel D. Test."

Our record shows one Robert B. Lawrence who was born 7th month, 24th day, 1823, in Isle of Wight County, Virginia, died 3rd month, 25th day, 1900, married Tacy Bates. Dates in the record would seem to indicate he was the son of Thomas and Isabel, who was Thomas' first wife,

Robert and Elizabeth (Denson) Lawrence were the parents of one child: Ann D. Lawrence, b 12th month, 31st day, 1811, died at the age of 58 years, 10 months, 14 days. Married 12th month, 27th day, 1843, to Daniel D. Test, b 8th month, 8th day, 1812.

5.

Daniel D. and Ann D. Test were the parents of five children:

Albert Barclay b 1st month, 5th day, 1845, d 6th month, 6th day, 1913, married Lydia Ann Fawcett on October 7, 1868, in Salem, Ohio. (Lydia was born Mar. 22, 1850, died Jan. 2, 1929). It may be noted here that, though the Lawrence branch of the family retained the old Quaker method of keeping dates, Grandmother Lydia Ann did not use this numerical system when she recorded her own date of marriage and birth, thus the other type of date is also used to record the date of her death which occurred at Mitchell, South Dakota.)  
 Mary L. Test, b 2nd month, 10th day, 1847, d 5th month, 14th day, 1916, unmarried.  
 John Strawn Test, b 6th month, 6th day, 1848, d 9th month, 16th day, 1916, married Martha E. Whinnery (b 8th month, 28th day, 1855) on 2nd month, 18th day, 1875.  
 Martha Test, b 10th month, 23rd day, 1849, d 2nd month, 28th day, 1905, married Thomas E. Stanley (b 4th month, 16th day, 1847) on 3rd month, 27th day, 1891. Martha was Thomas Stanley's second wife.  
 Deborah Test, b 2nd month, 17th day, 1856, d 10th month, 30th day, 1915, married T. Frank Hoopes (b 4th month, 19th day, 1857, died 4th month, 8th day, 1913). They were married on 2nd month, 17th day, 1881. Perhaps both Deborah and Frank Hoopes died at Hot Springs, S. Dakota.

Mary L. Test, the unmarried sister in the above family, lived for some time at the Hoopes home in western South Dakota, and died there. The Hoopes family lived in Salem, Ohio, until their children were grown, when they bought and "homesteaded" land near Hot Springs, S. Dakota.

 Albert Fawcett Test, b Mar. 10, 1881, d Aug. 19, 1942, married Maude Elizabeth Propst (b Oct. 26, 1880, daughter of Robert Lincoln and Edwina Thayer Propst) at Mynard, Neb. on June 26, 1906.  
 Walter, b Aug. 23, 1885, and died the same day at York, Neb.

The above family is the Marshalltown, Iowa, Test family. Emmett moved to Paullina and farmed there.

Thomas E. Stanley and Martha (called Mattie) Stanley were the parents of Lawrence D. Stanley b. Nov. 15, 1892, married Marie Louise Barthelot on Dec. 14, 1921, in Paris, France. The Stanley family lived at Whittier, Iowa, then Lawrence left to farm in California.

Florence Mary Test, b. July 3, 1901, married Markham Leon Young (b. Sept. 8, 1899, son of the same Thomas and Ida Young mentioned above, and brother of Thomas C. Young) on December 3, 1921, at Mitchell, South Dakota. Now living at 709 Hildreth, in Charles City, Iowa.

Lawrence Monroe Test b. October 6, 1905, named Monroe for his mother and his grandfather, who were given the name because of being descendants of the family of James Monroe, third president of the United States. Married Lois Geise (b. Mar. 7, 1913, daughter of Oscar and Edna Geise of Clark, S. Dakota) in November 1935, at Clark, South Dakota. Now living near Custer, South Dakota, on a ranch.

#### Hall's Notes on the Tests

The following pages contain Nathan Hall's record of the Tests, from the earliest family of that name to come to these shores.

In studying Mr. Hall's notes it has been interesting to see names that were already familiar. Our record of the Strawn family shows, in the sixth generation, a man with the unusual name, Enos. The Test record which follows shows, in the fifth generation, that Mary Test married Enos Strawn, undoubtedly the same man.

Members of the South Dakota branch of the Test family will be interested to note that two Fawcetts, Richard and William, are mentioned in the fifth generation of Mr. Hall's record. This is two generations before our grandmother, Lydia Ann Fawcett, was married to Albert Barclay Test, which union established our own branch of this family.

Nathan Hall, of 81 Price Avenue in Lansdowne, Pennsylvania, has developed an interest in the study of his own and his wife's families since he took this up as a hobby when he retired from active business a few years ago.



The reference material used has included copies of the records of Friends Meetings in London and vicinity, the extensive libraries of the Pennsylvania Historical Society and their Genealogical Society. But the principal source of information has been William Wade Hinshaw's "Encyclopedia of Friends Monthly Meetings."

## 1.

John Test was born somewhere in England in 1651. Elizabeth Sanders was also born in England in 1651. John and Elizabeth were married in London, in the Episcopal Church, in 1673.

There were many Tests and Sanders in the Society of Friends in London and vicinity at that time. These two may or may not have been members there. When they came to this country, Elizabeth must have joined the Philadelphia Meeting, as she was buried in the burying ground of the Society of Friends in Philadelphia, and marked as a member.

The date of John and Elizabeth's removal from England to this country is not given, but it is known that John was a merchant. He opened a store in Upland (now Chester) Pennsylvania, and was appointed sheriff of Upland before William Penn came over. After Penn's arrival and redivision of his territory, John was sheriff of Philadelphia. Evidently he lived in the city for a while as he is said to have built a brick house on the corner of Third and Chestnut. As the records show he sold lots to different people, he must have had a tract of some size.

John Test was sheriff for only one year and returned to his store in Chester. His name occurs many times in the Real Estate records as he seems to have bought large tracts and then divided them up and sold them in smaller amounts. His name is also found in the court records, we find him suing others for small amounts, perhaps store bills. In one case, we find John himself being sued for "one cask of pork, 470 pounds, decided in favor of the Plaintiff".

John also had a store about thirty miles south in New Castle, Delaware. He was interested in Real Estate across the river, as well, in Salem, New Jersey. He may have lived there for a while. No record has been found of his death and burial, but it may have been in Chester since records show that John, Junior's children were baptized there (St. Paul's church) and in the cemetery is a stone which says, "here lyeth the bodie of John Test", also another stone with John and Test, one above the other, all that can be made out. There were Johns in every generation so it is hard to place all of them.

John's first wife, Elizabeth Sanders, had died 12-12-1689. She was survived by only one child, John, Jr., and her husband.

John then married, late in 1690 or early in 1691, Grace (Wooley) Lippincott, about whom there is no information previous to this marriage. Grace and six children apparently survived John Test when he died, in 1706. John's will was filed for record in New Jersey on January 1, 1709, by John Bacon who married the widow.

Records in New Castle, Del., show Grace Test, the widow, was married in her home in New Castle by R. DeHass (Justice) on April 6, 1708, to John Bacon, of Salem, New Jersey. Meeting records are very incomplete and evidently some of the clerks failed to get all the items recorded, as Mr. Hall has examined the original books and failed to find anything about this Grace Test and her family becoming members, but from 1714 when her daughter Ann was married, we find account of their births, marriages, transfers, and deaths, on down until about 1925.

Grace's husband, John Bacon, also died. This item is reported in the Salem, New Jersey, Monthly Meeting, June 25, 1718. "Grace Bacon and Richard Woodnut published their intentions of marriage. The committee of inquiry was asked that care be taken concerning the child Grace had by John Bacon."

A comment upon the career of this Grace Wooley Lippincott Test Bacon Woodnut, who appears to have been the great-great-great-great-great-great grandmother of this writer. Mr. Hall remarked, "It seems that some of our ancestors were very much married."

## Fawcett - Ball

The following is the record of the Fawcetts and the Balls, grandmother Lydia Ann Test's family. Our earliest records are those of the Ball family, one member of which was George Washington's mother, Mary Ball Washington. Mary's parents were the great, great, great, great, great grandparents of this writer, if these calculations are correct.

The Fawcett family is of particular interest because of the reason they came here. The Fawcetts left France, their original home, in 1685, at the revocation of the Edict of Nantes, withdrawing the privilege of religious freedom to the French Protestants. Many left, some going to England, Ireland, Wales, United States and the West Indies. Some Fawcetts went to each place.

Three Fawcett brothers (Quakers) left Ireland and settled in Pennsylvania with William Penn, when they first arrived in this country. Later, their sons and grandsons went to Frederick County, Virginia. One brother bought 600 acres of Lord Fairfax, to whom the King of England had given that part of Virginia. Another brother bought 400 acres of land adjoining this 600-acre estate. This was between the Great North Mountain and the Little North Mountain and was called Fawcett's Gap, where the Fawcetts still owned property and lived in 1933. Edith Fawcett Zellely wrote in 1925, at Salem, Ohio, "The post office went by the name of Fawcett's Gap until laid down the last year."

Richard and Eunice (Fernley) Fawcett were married at Crooked Run, Virginia, in 1792. They bought land of Alexander Hamilton at Fawcett's Gap, Frederick County, Virginia, where they lived until moving to Salem, Ohio, December 15, 1807, with six children. Four more children were born in Ohio. This couple, Richard Fawcett and his wife, bought 112 acres of land from Samuel Davis for \$800.00. The abstract of this is from the United States to Samuel Davis, August 9, 1806, all of Section 31, signed by Thomas Jefferson, President, and James Madison, Secretary of State. Richard later owned several farms.

When the above Eunice and Richard came to Salem, Ohio, from Virginia, they lived in a log house. In 1810, they built a two-story brick house near the spring which was still in use in 1933. The house was also still in good condition and being used as a home in 1933. This was north of Salem (Ellsworth Street). Four generations of Fawcetts were born in the brick house. The above material on the Fawcetts was written by Edith F. Zellely of Salem, in 1925, with additions by Mrs. Sarah Koll Hewitt of Benton Harbor, Michigan, in 1933.

## Ball

Because of the large number of men named William Ball and Joseph Ball, they are numbered to prevent confusion: I, II, etc.

## 1.

The first Ball who appears on our record was William Ball, Lord of Barkham Manor, Berks, England. William Ball I died in 1480.

## 2.

Robert Ball, son of William Ball of Barkham, died in 1543.

## 3.

Robert Ball had two sons, William II, who died in 1550, and Edward Ball.

## 4.

John Ball, son of William II, married Alice Haynes and Agnes Holloway. John Ball died in 1599.

## 5.

John Ball had eight children, the record does not show to which wife they were born. They were: William III, Rachel, Elizabeth, Joan, John, Robert, Thomas, and Rachel. The name Rachel is given twice. It may be the first Rachel passed away before the later one was born, and the name given again to the youngest child in the family. If the list is correct, there could be no other explanation.

## 6.

The record is continued through John's son, also John Ball, who married Elizabeth Webb. This John Ball died in 1628. He was the father of eleven children: William IV, Thomas, George, Richard, Samuel, Rachel, Elizabeth, Susan, Alice, Dorothea, and Mary. Our record is continued through William IV.

7.

William Ball IV, the eldest of John's eleven children, died in 1634. His son, Colonel William Ball (V) was married July 2, 1638, to Hannah Atherald. They emigrated to Virginia in 1657 and settled at Millenbeck Plantation, on the Rappahanock River. (The record does not state from what point they emigrated to Virginia.) They had four children. Colonel Ball died in 1680. The Ball family owned and lived upon this estate on the Rappahanock River for many generations. At this time, in the year 1951, one Arthur Godfrey, well-known radio and television personality, is living on a farm near Leesburg, Virginia, which he says is a part of the old Ball estate. There is a Ball family burial plot on the farm owned by Mr. Godfrey.

Colonel William Ball (V) had a brother, Edward Ball, who also settled in Virginia. He had ten children.

8.

The children of Colonel William Ball (V) and Hannah were: Captain William Ball (VI) born June 2, 1641, died September 30, 1694. Colonel Joseph Ball (I) of Lancaster County, Virginia, born May 24, 1649, died 1711. He married Mary Johnson. The other two children were James and Hannah Ball.

Edward Ball, the brother who also lived in Virginia, had ten children, of whom we have only the following named in our record: Caleb, Abigail, Joseph, a cousin of Joseph I named above, Lydia, Moses and Thomas.

9.

Children of William VI and Joseph I are both listed in this generation. William had nine and Joseph had four. William's children were: William VII, Richard, James, Joseph II, George, Samuel, David, Stretchley, and Margaret. There may have been another daughter named Sarah.

Joseph's (I) children were: Hannah, Jonathan, Mary, and Susanna. Of this generation we are concerned with Samuel, William's sixth son, and Mary, Joseph's third child.

10.

Mary Ball was married March 6, 1730, to Augustine Washington. Their six children were George, Samuel, John Augustine, Charles, Elizabeth and Mildred. Our record does not concern itself further with this branch of the family--it's later history is common enough to be found elsewhere in history. Mary Ball Washington died August 25, 1789, only a few months after her son had been inaugurated as the nation's first president.

Samuel Ball, Mary's cousin, was the father of eight children: William VIII, born 1718, died in 1785, married Martha Bromfield in 1741; John, born in 1720, in Culpepper County, Virginia, died in Pennsylvania, married Mary Richards; Hannah, who married Joseph Holloway, Abigail, who married Peter Gilbert; Mary, who married George Smith; Sarah, who married Paul Custer; Anna, who married John Campbell, and Elizabeth, who remained unmarried.

11.

John and Mary (Richards) Ball had a son, Joseph III, who married Sarah Richards. He left no heirs but left a large estate.

William VIII and Martha (Bromfield) Ball had seven children, the eldest of whom was our ancestor. Their children were: John, who married Sarah Ellen Payne; Sarah, who married John Daniels; Susan, who married Samuel Fisher; Elizabeth, who married Isaac Suppler; Thomas, who married Mary Reed; Martha, who married Moses Tocum; and William IX, born in 1762, who married Mary Key in 1788.

12.

William IX, and Mary (Key) Ball had four children: John, Aaron, Sarah, who married a man named Ferguson; and William D. Ball X, who married Barbara Hall. This is the end of this branch of the family in our record.

The John Ball family with whom we are concerned, eldest son of William VIII and Martha, and brother of William IX, died about 1794. This is the only date given in the record of this generation. He married Sarah Ellen Payne and they had a son, Nathan, born August 7, 1762.

Nathan Ball married Atlantic Allen, who was so named because she was born during the voyage when her parents were travelling to this country to live. Atlantic's relatives lived in Maryland. Atlantic was born in 1762. Nathan left Bucks County, Pennsylvania, to live in Fayette County, Pennsylvania, and from there he later went to live in Columbian County, Ohio.

14.

Nathan and Atlantic Ball had three children: Joseph IV, Hannah, and Benjamin. Hannah was born May 2, 1798, died December 29, 1846. She was married to David Fawcett on May 24, 1815.

15.

Hannah and David Fawcett had seven children, of whom the eldest son, Eli, was our ancestor. From this generation on, the story of the Ball family joins the story of the Fawcetts and eventually becomes the story of the South Dakota branch of the Test family. Eli Fawcett was the father of Lydia Ann, our grandmother.

## Fawcett

1.

The earliest record in the Fawcett genealogy is that of John Fawcett who was married to Judith Shwartz on May 19, 1682.

2.

Thomas Fawcett, son of John and Judith, married Lydia Boyes on April 2, 1708.

3.

John Fawcett, son of Thomas and Lydia, married Sarah Branson in 1783. The record shows another son, Joseph, but there is no record of his marriage. Joseph was the third son. The second son, Richard, married Rachel, whose maiden name is unknown.

4.

Thomas Fawcett was the son of Richard and Rachel. No record is given of his marriage. Another son, Richard, was born September 22, 1771 and died August 26, 1845. Richard married Eunice Fernley. They were married at Crooked Run, Virginia, on December 12, 1792. Eunice Fernley was born November 26, 1776, died September 17, 1839.

5.

Richard and Eunice had ten children. The first six were born in Virginia before 1807, the other four were born in Salem, Ohio. David was born November 11, 1793. The others were: Jonathan, Ann, William, Esther, Drusilla, Martha, Richard (who was Edith Fawcett Zelle's father), Josiah, and Eunice.

David, the eldest son of Richard and Eunice, married Hannah Ball, the daughter of Nathan and Atlantic Ball. David died February 5, 1862 and Hannah died in December of 1846. Hannah was born May 2, 1798.

6.

The children of David and Hannah (Ball) Fawcett were:

Ann Fawcett b April 4, 1816, died April 4, 1886, remained unmarried,

Eli Fawcett b Jan 22, 1818, d Jan 21, 1904, married Sarah Eliza Satterthwait in Salem, Ohio, on Mar. 16, 1846. (Sarah Eliza was b Apr. 6, 1827, d Jan. 27, 1854, daughter of David and Sarah Eliza Moore Satterthwait).

Nathan Fawcett, no record of birth and death dates, apparently remained unmarried.

No record given of Nathan's marriage.

Lydia Fawcett b Nov. 3, 1822, d Mar. 16, 1889, married Hutchin Satterthwait, who was also a child of the above David and Sarah Eliza Moore Satterthwait. Married Apr. 29, 1846 at Salem, Ohio.

Joseph Fawcett b Aug. 31, 1825, d. Feb. 13, 1899, married Mary Fisher. (Mary b Apr. 24, 1830, d Mar. 25, 1908) on May 21, 1862.

Sarah Fawcett b May 19, 1828, died in 1893, married Louis Street who died in 1892.

Eunice Fawcett b May 9, 1837, d Jan. 3, 1922, married David Street (probably a brother of Louis Street) who died in 1913. These were Sybil and Grace Street's parents.

The Sarah and Louis Street of this generation were the couple who were missionaries in Madagascar under the Church of England.

## 7.

Eli and Sarah Eliza (Satterthwait) Fawcett were the parents of:

Hannah Fawcett b Jan. 4, 1847, d Aug. 17, 1935, married Joseph Koll (son of David and Julia S. Koll) on August 16, 1866, in Philadelphia.

Lydia Ann Fawcett b Mar. 22, 1850, d Jan. 2, 1929, in Mitchell, S. Dakota, married Albert Barclay Test on October 7, 1868, in Salem, Ohio. (Albert b Jan. 5, 1845, d June 6, 1913.)

David Fawcett b Sept. 14, 1852, d July 14, 1915, married Harriet Bossart, daughter of Mr. and Mrs. Jerry Bossart on October 1, 1873, in Salem, Ohio.

After the death of Sarah Eliza (Satterthwait) Fawcett, Eli married Susan Myers (b June 3, 1835 in Lisbon, Ohio, died Feb. 4, 1911 in Colorado). They were married in August of 1862 in Salem, Ohio. Two children were born of this marriage.

Paulina Fawcett b in Salem, Ohio Oct. 25, 1864, called Lina, remained unmarried, no record of her death.

Louis Fawcett b June 9, 1869, d Oct. 16, 1929, married Emma Keifer (b Nov. 2, 1878, daughter of Daniel R. and Louise Bayer Keifer) on September 6, 1906.

Hutchin and Lydia (Fawcett) Satterthwait were the parents of:

David F. Satterthwait b Jan. 3, 1847, d Jan. 30, 1913, at Punta Gorda, Fla.

Sarah B. Satterthwait b May 21, 1850, d Nov. 24, 1867, at Salem, Ohio.

Mary Ella Satterthwait b April 25, 1853, d Feb. 7, 1898.

Edgar Satterthwait b Sept. 13, 1855, d Aug. 5, 1935, married Elinor Sybil Street, daughter of David and Eunice Street at Belmont, N. Y. on Aug. 9, 1910.
